### STOCK PHOTOGRAPHY LICENSE AGREEMENT

The following License is between [redacted] Inc. ("Licensee"), having offices located at [redacted], San Francisco, CA 94111 and XXXX ("Licensor"), located at XXX:

Whereas, the Licensor is the sole and exclusive owner of the copyrights in those digital scans, photographs, transparencies, slides or slide duplicates and/or images described as follows: \_\_\_\_\_ ("Images"), and

Whereas, the Licensee wishes to acquire rights to reproduce the Images under the terms and conditions set forth in this License in the book currently entitled [redacted] (the "Work"), including any and all marketing and promotion of the Work by either the Licensee and/or its assigns.

Therefore, it is hereby agreed as follows:

License (usage)

- 1. Rights:** Licensor hereby grants the Licensee the non-exclusive, worldwide rights in all languages to incorporate the Images into the Work, and to reproduce and distribute the Images as part of the Work and all future revisions and editions thereof, including bindup editions which include the Work along with related works. *Read this carefully, it was not what I negotiated*
- 2. Ownership:** The Licensee acknowledges that the Licensor is the owner of all right, title and interest in the Images and agrees that it shall take no action inconsistent with or which will in any way impair or undermine the Licensor's ownership. The rights granted pursuant to the provisions of the License shall not in any respect confer upon the Licensee any ownership in the Images. *means that they aren't asking for copyright*
- 3. Warranty:** The Licensor represents that the Images are original, and that Licensee's use of the Images as described herein shall not infringe upon any copyright or violate any personal or property rights of any third person. Licensor warrants that the Images are not in the public domain and that Licensor has the full power and authority to enter into this License and grant the rights herein contained. *means I took the photo, have the right to license it, and have releases if needed*
- 4. Modification:** Licensee may crop, edit, flip or otherwise adjust the Images as needed in order to render the Images suitable for publication in the Work, for size and design requirements. Licensee may digitally scan and store the Images in connection with permitted uses of the Images.
- 5. Copyright Notice:** Licensee shall include a full copyright citation with other facts of publication in the back matter of the Work. Licensor shall provide Licensee with full instructions as to how use of the Images should be credited in the Work. The appearance of the copyright notice shall be at the sole discretion of the Licensee. *They decide if + where it is displayed*
- 6. Compensation and Payment:** Incorporation of the Images into the Work is at the sole discretion of Licensee. Upon publication of the Images in the Work and receipt of an invoice from Licensor, Licensee agrees to pay Licensor the sum of US \$XXX.00. *I negotiated payment within 30 days of invoice. This change must be added in writing.*
- 7. Entire agreement:** This License sets forth the entire understanding concerning use of the Images between the parties, there being no other terms, conditions, warranties, or representations other than those contained in this License. This Agreement is executed in accordance with the laws of the State of California. Any change to this Agreement must be made in writing and signed by all parties. Licensor waives the right to seek or obtain any injunctive or other equitable relief in connection with the use of the Images by Licensee.
- 8. Sample Copy:** Upon publication Licensee shall supply 1 complimentary copy of the Work to Licensor. *Any changes must be added. Verbal agreements mean nothing*
