Primary usage: To create images of attorneys and staff of  for use on their website. Usage term is five years.

The photographic services included are:

1. six environmental portraits of the lawyers taken in and around Pioneer Square;
2. six traditional vertical head shots of the lawyers;
3. fifteen stylized photographs of the staff in groups around the office;
4. details around the office

Secondary usage: the license for the head shots of the attorneys includes distribution to trade publications, up to 30 times per year. Mandatory credit will read: ©Natalie Fobes, www.fobesphoto.com These images will be supplied by the photographer as digital files at 300 ppi. Consumer magazines may license directly images from the photographer.

The creative fee includes up to two days of photography and one day of processing and optimizing. Final file preparation and retouching is billed at \$50 per selected image.

If additional shoot days are needed the rate will be \$1300 plus expenses.

Photographer retains copyright. All usages not specifically listed remain with the photographer.
